

OFFICIAL CONTEST RULES

1. ELIGIBILITY:

- a. To be eligible to enter and win the Prize, you must be a Grade 7-12 student in the Newfoundland and Labrador school system.
- b. Each individual or group may enter only once.
- c. The school name and location, along with the name of each student in the group (up to 4 students) and their grade level must be included.
- d. You are not eligible to enter or win the prize, if your parent/guardian is an employee of the takeCHARGE team in either Newfoundland Power or Newfoundland & Labrador Hydro. For purposes of these rules, an employee of the takeCHARGE team means position titles of Energy Conservation.
- e. Video submissions should be no longer than 5 minutes in length.

2. HOW TO ENTER: The student(s) must enter the contest via the online submission form at <https://takechargenl.ca/resources/for-kids/k-c-start-school-contest-grades-7-12/> or by mail to the school's electricity service provider (Newfoundland Power or Newfoundland & Labrador Hydro) by 4:00 PM (Newfoundland Standard Time) Friday, February 27, 2026. 3. CRITERIA FOR JUDGING:

- a. Appearance and creativity
- b. Is the entry well designed and creative?
- c. Accuracy of the message
- d. Does it accurately capture why saving energy is important and provide correct tips on how to save energy?
- e. Effectiveness
- f. Would this entry inspire their peers to take action?

4. PRIZES: There will be one Grand Prize winner of Chapter's Gift Cards valued at \$100 per student (up to 4 students) in each of the Sponsors' service territories. (The "Sponsors" are Newfoundland Power Inc. and Newfoundland & Labrador Hydro.)
